**One Day Cash-Out Casino Trips:** Advanced reservations are required. Advanced payment in full is required no later than the day before departure, except Four Winds which payment is due at 14 days before departure. You can prepay with Visa, Mastercard, Discover, American Express or check. If you need to cancel your day trip, please make sure to give Happy Times Tours & Experiences a call and let us know (if it is after hours, please leave a message with your name, date of trip, casino destination, and contact phone number). If you call to cancel your day trip before departure, we will transfer your money to another day trip (money is transferrable one time only). Payments for Four Winds Casino trips will be non-refundable at 14 days prior to departure. We understand issues come up; however, we will be tracking repeat no shows and reserve the right to refuse service to habitual no shows. If you do not call before departure to cancel, you will not be able to transfer the money. Ticketed Events (such as sporting events or horse races): There will be no refunds for cancellation unless a replacement can be found.

**Daycations (one-day, non-gaming trips), Milwaukee Experience Tours (including Schlemiel, Schlimazel, MKE):** Advanced reservations are required and are accepted on a first-come, first-serve basis.
